Financial Support

LapDog Club, on behalf of its local Chapters, proudly contributes to qualified animal charities approved by the Club. The profiles of Registered charities are provided for review by LapDog Club Chapters, which annually designate the organizations to be supported by donations made to the Chapters.

Support is provided through two sources:

- 10% of all *LapDog Club Boutique* sales and *LapDogClub.com* advertising revenues during each calendar year is divided equally among the Club's registered charities.
- LapDog Club consolidates charity donations made to its Chapters and disburses the funds, less a nominal 1% administrative fee, quarterly to the charities designated by the Chapters and donors.

All funds and disbursements are in U.S. dollars.

Registration

Charity organizations headquartered in the United States or Canada may submit this Application for consideration. Applicants will receive written confirmation of application status by email or postal service in 10-14 business days. Accepted organizations will receive a *LapDog Club Charity Registration Number*, which should be referenced in any correspondence with the Club.

Charity Organization Requirements:

- At least 80% of charitable giving must be disbursed specifically for the benefit or well being of animals, or the support of humanitarian purposes involving animals, such as seeing-eye dog, senior companion and pet therapy programs.
- At least 70% of organization's revenues must be disbursed for direct charitable purposes.
- Organization must annually provide proof of licensing or government recognition as a not-for-profit charity organization in good standing. Organizations that have filed for, but have not yet received official confirmation of licensing or recognition, will be considered for provisional registration.
- Organization must provide verification of donations to donors who submit checks payable directly to the organization, in a form acceptable to government tax authorities.
